Highlights and deliverables:

Access to fresh water and sanitation

Improved Sanitation: RBN continues to look into other funding mechanisms to improve sanitation in the RBN villages.

Monitoring of the existing RBN sewer plant in Phokeng and Thekwane is an ongoing activity implemented by Infrastructure Maintenance department. By the end of the 2nd quarter of 2018, Infrastructure Maintenance had received a total of 6 sewer treatment reports and all identified issues and risks were resolved.


Access to improved water: Provision of clean water to every community member continues to be a priority to the RBN organisation

Infrastructure Maintenance continues to ensure that households in the Bafokeng land have access to safe drinking water. By ensuring that all reservoirs are filled as well as maintaining reticulation systems and pump stations.

The Lefaragatihe Old Pump House Upgrade Phase 2 & 3 project is 81% complete and its planned completion date is the 31st of August 2018. The upgrade will increase capacity of the pump station thus increasing supply to Masosobane and Lefaragatihe. Currently the pumps only transfer 7200m³ per day, not enough to supply both areas.

Infrastructure Maintenance continued to ensure that water loss and wastage is minimized by attending to all reported burst pipes and water leaks.

Analysis of general plumbing repairs in the 1st and 2nd quarters of 2018:



- The number of reported pipe bursts in RBN increases quarterly, and Infrastructure Maintenance reported that the main contributor is the aging infrastructure.
- RBN spent R5.6m in general plumbing and R54.1m in bulk water purchase in the 1st and 2nd quarters of 2018.

Challenges:

- Rustenburg Local Municipality (RLM) delay in signing the Water Service Level Agreement (SLA).
- Aging infrastructure highly contributes to RBN water loss.
- Households' water leaks is another major challenge contributing to water loss.

- Implementation of the water strategy;
- Continuous response to reported water leaks; and
- Completion of Lefaragatlhe old Pump House Upgrade project.

Highlights and deliverables:

Health and Social Services Department (HSDS) 2nd Quarter Projects

 Based on the high number of child neglect and child abuse trends picked up by the social workers through their trend analysis and casework services.
 HSDS social workers then facilitated a child protection awareness campaign. A total of 2,789 learners were reached in 8 RBN schools and educate learners on issues of child neglect and how to seek help. The campaign ran concurrently with the National Child Protection week.



The establishment of Community

Nutrition and Development Centre project run by HSDS is almost complete with progress percentage of **83.5%.** The centre will serve a purpose of feeding the needy under the government Provincial Food distribution programme (PFDC) to contribute in alleviating poverty in RBN.

HSDS is also in the process of establishing a Place of Safety to temporarily house abused, neglected and abandoned children. Currently the identified site is being renovated to meet the stipulated standard set by the Department of Social Development. Project estimated date of completion is end of November 2018.

Caring of the Aged

To date HSDS has supported the elderly in RBN by providing them with 4,198 food plates by end of 2nd quarter of 2018. Furthermore HSDS care givers also conduct regular home visits to the elderly to offer them emotional and well-being support. To date the programme benefits approximately 390 elderly people in RBN.

Protection for the most vulnerable continues...

Victim Empowerment:

The victim empowerment programme supported 890 victims up to the end of the 2nd quarter of 2018. With a total of 1,070 counselling sessions and assessments conducted.

Casework/intake services: Casework services were deployed as part of HSDS's initiative to strengthen the family unit by empowering and equipping individuals, couples and the community to be able to resolve their own social problems. The below interventions are limited to Capital and Northern regions, the Casework Programme for North East and South East regions has been placed On-hold due to lack of manpower.

- A total of **339** cases were assessed by the end of 2nd quarter of 2018 with **141** cases being eligible for further counselling intervention.
- Of all the cases received and assessed 58 home visits were done by the social worker for further assessment.

People with Disabilities (PwD):

HSDS continues to maintain and update the PwD database, currently there are 1,234 PwD in the database.

Social services

- By the end of the 2nd quarter of 2018, HSDS through the Social Relief Programme had given out
 42 food parcels to needy families as another form of alleviating poverty in the RBN community.
- Other initiatives that are being implemented towards alleviating poverty in RBN under the Social Services Programme are: "Jaya O Jale" (An initiative to empower poor community members to establish their own backyard gardens and alleviate poverty) and refurbishment of Macharora vegetable gardens.

Challenges:

None reported

- Renovation of a house at Luka to be utilized as a Place of Safety;
- Facilitate Marriage Workshop to enrich marriages in RBN;
- Psychosocial Group work at different regions; and
- Facilitate 3 community outreach services organised by HSDS managers, Primary Health care Unit and EMRS.

Highlights and deliverables:

Royal Bafokeng Institute (RBI) is mandated to ensure improved, internationally bench-Marked standards of education through continuous training of teachers, the augmentation of the current public offering education through the resourcing and the deployment of subject specialists employed by RBI to assist teachers in the schools. At the end of 2nd quarter of 2018 RBI adopted business goals described below to assist with reaching their strategic objectives.

Business goal 1: Establishment and development of sound foundations for education: The Early Childhood Development programme under RBI focuses amongst other activities on establishing ECD centres in all RBN regions to impact on Early Childhood Development and on foundation phase teaching and learning to guarantee learner progress.

Business goal 2: Maintain and develop an affordable school model (Kitsong): RBI continues to strive to retain a keen interest and active role in developing Kitsong affordable school model. Kitsong has enrolled **217** learners from grade 8 to grade 12 in the current year.


Kitsong 2018 half year results: Kitsong learners have maintained an average pass rate of **100%** across all grades.

Access to uplifting learning opportunities continues...

As a form of intervention, RBI has entered into a Mathematics and Science partnership with Kutlwanong. The focus being to bring a *"peripheral benefit of teacher and resource development in Mathematics and Science to RBN schools"*.

In the 1st quarter of 2018, **120** grade 11 learners in Physical Science and **135** learners in Mathematics were nominated from selected Bafokeng schools to take part in the Kutlwanong Mathematics and Physical Science Development Programme. Of the 120 learners in physical science, **96** learners passed the half year assessment with over **70** % whereas in mathematics **87** learners passed with over **70%**.



Technical & Vocational: This unit delivers reliable quality training to Bafokeng youth and is currently developing the Maile campus to accommodate the extension of the construction programme to offer higher level of apprenticeship.

Royal Bafokeng Sporting highlights:

Royal Bafokeng Sports (RBS) continues to offer sporting activities in five sporting codes (Athletics, Netball, Basketball, Martial Arts and Disability Sport) across all RBN regions. Their continued efforts are highlighted on the achievements of both the participants as well as the coaches. RBS plays a major role in sport talent identification and development.

- Rorisang Ramonnye was selected to represent RBS in the athletics world cup in London in July 2018. Unfortunately due to injury she was ruled out of the competition.
- Kabelo Mohlosi is going to represent South Africa in the African championships in Nigeria between July and August 2018, and he obtained the 5th position.
- Jeffery Ntsimane participated in the comrade marathon that started in Pietermaritzburg and ended in Durban on the 10th of July 2018 and he finished the race.
- The Royal Bafokeng Jr. NBA U19 Boys & Girls Teams' attended the Sport Empowerment Economic Development (SEED) Basketball Classic Tournament hosted in April at African Leadership Academy (ALA), Johannesburg. Both teams came out victorious and claimed gold in the 1st SEED-ALA Basketball Classic Tournament.

Coach the Coach: The focus on sport development is not only on the players, but our coaches also receive continuous development to ensure they are well skilled to train the players.

Coach Ronny Letlhake attended a Generic Sports Coaching Workshop which took place from the the 2nd to the ^{3rd} of June 2018 at the University of Potchefstroom. He also participated in the Sport Team Managers` workshop at Olympia Park Stadium in Rustenburg where he was awarded the certificate in team managers in athletics. Furthermore 5 other coaches attended ASA level 1 coaching and 3 coaches were affiliated to the National Coaching certificate in Bloemfontein.

Sports Academy: Subsequent to the approval of the operational budget after the Academy joined RBS, RBS Academy continued with roll out of the pre-planned activities.

The team participated on the SAFA SAB Regional League and ended in position seven (7) as they had targeted to hold the eighth (8) spot out of 16 teams.

 - Commence training for Aftercare Project;
 - Implement new policies and protocols at Kitsong School and commence recruitment for 2019, with the intention of bringing the school roll up to at least 250 learners;
 - Begin implementation of ECD programme extension;
 - Develop the CPD, IT Training Centre and Science Centre considerations for Akanyang;
 - (Professional Development Programmes for Mathematics and Science Educators to commence before the end of July 2018);
 - Develop our Post Schools unit to include facilitation of access to training in general, in addition to what we provide as RBI. Complete works at Maile Campus; and
 - Student & Graduate Support Services to begin publishing information for 2019 university admission.

Highlights and deliverables:

HSDS has and is continuing to disseminate health information on Listeriosis and handwashing to RBN food handlers, caterers, and care givers. Many RBN organisations were reached, including the aged centres, Orphaned and Vulnerable Children Centres and some of the local catering companies. The main emphasis was to keep the community informed and to prevent further outbreaks of Listeriosis. Currently no cases of the disease have been reported throughout all RBN health care facilities.

 Health care promoters continue to educate people on emerging health concerns throughout the RBN. By the end of 2nd quarter of 2018, 42,558 community members were reached through the Health Promotion Education Programme. The figures include all RBN regions.




The number consultations in all RBN 7 clinics including mobile clinics was reported to be 87,135 for 2nd quarter of 2018 only.

✤ Total number of new recorded HIV patients in RBN clinics was reported as 620 in the 1st quarter of 2018 and 592 in the 2nd quarter of 2018. The number indicates that more interventions and education on HIV prevention is needed to reduce the HIV rate in RBN.

HSDS reported on chronic illness consultations as follows;

Continued efforts were taken to prevent the spread of infectious diseases which may lead to illnesses, disability or even death by ensuring that all children in the RBN are fully immunised.

- HSDS conducted 125 immunisation awareness campaigns in all 5 RBN regions between January 2018 and June 2018.
- A total of 22,765 children were immunised in the Bafokeng based clinics, mobile clinics and schools by the end of the 2nd quarter of 2018. This is to ensure that all children, including those who defaulted on immunisation are ultimately immunised.

<u>NOTE</u>: the percentage of compliance to immunisation cannot be reported on as children can also be immunised outside Bafokeng health facilities.

Emergency Medical Rescue Services (EMRS)

HSDS continues to render efficient emergency medical rescue services within the jurisdiction of the RBN.

- In 2nd quarter of 2018 EMRS dispatched a total of 2,045 calls received via the call centre. Out of all the dispatched calls, 1,644 were attended to and conveyed 1,167 patients to health centres and hospitals.
- The unit rendered emergency medical rescue services at **18** events including Dumela Phokeng in all 5 regions and Youth Kgothakgothe.

Challenges:

- Continuous monitoring of Listeriosis, especially in areas where food is being prepared; and
- Facilitation of Psycho Social Group work in all RBN regions.



Highlights and deliverables:

The alignment of the Geographical Information System (GIS) cadastral maps with the stand data as received from the PULA 2016 survey has been completed. The project was intended to assist Development Planning to align the GIS with PULA data and to ensure that data can be easily retrieved when need for process such as water billing in RBN. From the project, **21,600** of the RBN population was linked to the stand database.

The unit continues to monitor applicants adherence to procedures and guidelines when applying for stands, rezoning and subdivisions.

In the 2nd quarter of 2018, Development Planning received 104 residential stand applications and allocated 23 residential stands, a further 12 business stand applications were received and 8 were allocated. The volume of applications out ways the number of allocations. As it stands, Development Planning is in the process of counting, assessing and documenting the back-log.



Access to adequate housing continues...

Challenges:

- The finalisation of the stand allocation workflow and the issues relating to land use management in terms of verification of the documents before stands can be allocated.

- Ensure that land is allocated in line with RBN Master Plan;
- Capturing of stand applications backlog on the GIS system;
- Establishment of the deeds office; and
- Development of the Land Management Programme.



Highlights and major deliverables:

Protective Services continued to combat crime by means of conducting joint crime operations within the RBN jurisdiction and responding to all crime related complaints from the RBN community members.

- In the 2nd quarter of 2018 Reaction Force conducted **17** joint crime operations with SAPS and Public Safety. On average joint crime fighting operations with the mentioned crime fighting stakeholders occurs every sixth day, the unit reported that the major reason for the decrease in joint operations is the unavailability of law enforcement stakeholders.
- The unit further reported to have received 1,054 crime related community calls during the 2nd quarter of 2018.
- They attended (physical and verbal response) 968 incidents in the 2nd quarter of 2018, 7% more than in the 1st quarter of 2018. This is because there is high crime rate, particularly during April which has several public holidays during which public drinking activities normally increases.
- Reaction Force arrested 184 crime suspects in the 2nd quarter of 2018, while in the 1st quarter of 2018, only 146 arrests were made. This confirms high crime rate during the public holiday season.
- 149 cases as identified under the Criminal Procedures Act were investigated and completed in the 2nd quarter (handed over to court).

A safe, secure and fraud-free community continues....

Protective Services continues to contribute to a corruption free environment in the RBN, by investigating **100%** of all alleged corruption/theft/fraud cases.

Under the Land Monitoring Unit, Protective Services reported having conducted 1,902 land operations during the 2nd quarter of 2018. These include demolition of illegal structures, serving of notices to RBN land trespassers and destroying expired food stuff from tuckshops and general dealers.

Challenges:

- Bottleneck of many land related cases awaiting trial at the Tribal Court.
- Illegal use of land because of lack of order on land application procedures.

- Prevention of illegal penetration of any RBN site guarded by the departmental guarding division; and
- Manage the attendance of every crime scene/incident in a swift, qualitative manner.

Highlights and major deliverables:

Waste Collection

Waste management is important because improperly stored waste can cause health and safety problems. RBN continues to collect waste in **19,671** stands in all regions and villages. Waste removal trucks collected **970** tons of waste in the 2nd quarter of 2018, this only includes households, businesses, schools and clinics. One of the many initiatives aimed at creating a clean, green and healthy environment.

To ensure compliance with the Environment Impact Assessment (EIA) policies and regulations, Land Use Management reviewed all submitted EIA reports.

Challenges:

- The challenge with the cleaning campaign is the budget. The project is awaiting Office of Kgosi to allocate the budget for this project. Cleaning of the borrow pits is also a challenge due to human resources.
- Illegal dumping of rubble and waste in open spaces.

OPMO & Research

The OPMO continues to monitor, update and maintain the RBN Central Management Systems (Ops system and RBN Database)

- Ops system: an average of 93% on project and programme updates was reported in the 2nd quarter of 2018.
- **RBN Database:** the department continued to monitor the number of individuals captured on the system. As at end June 2018, there were **39,569** individuals on the database.

To optimise the utilisation of management information in the organisation the OPMO develop **10** management reports in the 2nd quarter of 2018 namely; 1 RBN Quarterly Performance Report, 3 online OPMO Monthly Reports, 3 Makgotla Reports, 1 Manco Report and 1 Ad-Hoc report.

Research facilitated a focus group study for the Loyalty Programme on behalf of OPMO. The objective of the study was to gain insight on whether the community members would have interest in participating in the Loyalty Programme.

Legal

Legal department facilitated the negotiation and finalisation of service level agreements on behalf of RBN entities and departments and monitors legislative impacts on the operations of RBN.

- In the 2nd quarter of 2018, Legal department prepared and submitted comments on the review of section 25 of the constitution of Republic South Africa regarding the expropriation of land without compensation, which is currently under review.
- Legal also facilitated an audit on existing RBN trademarks and registered new trademarks for RBNDT, Lebone II, Moumo and Cross Point Trading (Royal Marang Hotel).
- The department compiled **11** contracts and SLA's across all client departments.

The department continues to manage all civil, criminal and labour litigations on behalf of RBN.

By the end of the 2nd quarter of 2018, Legal department reported 3 litigious matters finalised, and
 6 pending litigious matters.

An effective, professional administration continues...

Finance

Finance department ensured continued compliance with policies, directives, frameworks, statutory and procedures relevant to expenditure management in the organisation.

- The department completed the Disposal of RBN Obsolete Assets project, which benefitted 18 RBN Makgotla, 5 RBN NGOs and 5 RBN Cooperatives. A total of R 90,547 was raised from recycling remaining assets.
- The compilation of the 2017 RBN group annual financial statements audit commenced in the 1st quarter of 2018 and is still in progress, no issue have been raised thus far.

Procurement

Procurement department ensured efficient, effective, uniform and duly authorised procurement of all assets, goods and services required for the proper functioning of RBN affairs.

In the 2nd quarter of 2018 Procurement generated 591 purchase orders.

<u>NOTE:</u> No tenders were allocated in both 1st and 2nd quarter of 2018.

Human Resource (HR)

Human Resource recruitments continued to ensure best HR practices in the RBN.

- By the end of 2nd quarter of 2018, HR received a total of **353** of the 400 expected performance agreements from RBA. Efforts are being made to collect the outstanding **47** agreements.
- HR collected a total of only 228 performance management assessments of the 400 expected performance assessment from RBA. There are still 172 more assessments to be submitted.

Information Technology (ICT)

IT continues to support, maintain and monitor the organizational network infrastructure.

- ICT has maintained an average of 95% internet and telecom system up-time at the Royal Bafokeng Civic Centre.
- **332** ICT related incidents logged by employees were resolved via Helpdesk.
- By the end of 2nd quarter of 2018 ICT had installed a backup system into 312 employees' laptops and desktops.

An effective, professional administration continues...

Challenges:

- Shared Services reported the lack of budget availability in most departments in the Shared Services cluster as impacting on services rendered.
- Finance reported budgets not appearing on SAGE system as a challenge, which causes a delay in preparation of monthly departmental Income and Expenditure Reports as since are now being done manually.
- Finance also reported the delay in collection of used tyres by identified farmers as a challenge with regards to disposal of obsolete assets.
- Procurement reported that some departments submit high value item requisitions on very urgent basis most of the time, this practice impacts negatively on fair competitive pricing. Furthermore some departments are yet to adhere to the controls and safe custody of vehicles or fleet allocated to them despite workshops on transport usage and controls. Meetings were held with these departments at the beginning of 2018.
- Human Resource reported that some departments failed to meet the performance assessment deadline and submitted their documents late.
- Insufficient budget allocation to cover most of ICT expenditure in line with RBN strategic demands is a challenge for this department.
- ICT is currently still awaiting the appointment of the Senior ICT Technician.
- Low ICT staff morale and lack of cohesion impact on the departments` performance.
- Lack of training and internal capacity building to keep abreast with technological developments due to budget constraints.

Infrastructure Maintenance continued to monitor the construction of roads and storm water structures done by Rustenburg Local Municipality to ensure that they are of good standard and due process is being followed.

Royal Bafokeng Enterprise Development (RBED): RBED continued to develop Bafokeng SMMEs into self-sustainable businesses through implementation of various interventions



✤ In the 2nd quarter of 2018, 9 of Local SMMEs where exhibited at Rusternburg Mining and Technical Expo.The purpose of the expo was to give local SMMEs exposure to new market oppertunities, and in this case the mines were the clients.

♦ RBED in partenership with Coca cola initiated a Youth Enterpreneurship project, where by 45 Bafokeng youth were identified to undergo a series of business developmental training, and by the end of 2nd quarter 4 youth went through the final emerging face, where they were given the priviledge of starting and managing their own businesses. The project is currently 80.4% percent to completion.

- Execution of the Bleskop Chrome Loading Bay and Siding Upgrade project;
- Continuation of the Marang Housing Development project; and
- Finalise all legal agreements and engagements with farmers for the Veggies pilot project.

Recommendations

PLAN 35 TARGETS AND BASELINE INFORMATION:

Most of plan 35 targets have been populated. However the outstanding targets has to be finalised and populated accordingly in collaboration with the technical experts. Plan 35 will give us a map of where we are going and will measure progress and how well we are doing against the set targets.
